INFORMATION NEEDED FOR YOUR EQUINE APPRAISAL

Thank you for contacting me about doing an appraisal for your horse. I am a Senior Certified Appraiser with the American Society of Equine Appraisers, and I have been doing equine appraisals for over 25 years.

Please answer the questions below with as much detail as you can. Once I complete the appraisal, I will email you a full report. I will also send you the signed IRS 8283 Form you need for your taxes if you are donating your horse to a 501C3 program.

1. Name of horse:

(Registered name, Show name, and Barn name) Also, does the horse have any prior names?

2. Basic description:

Sex, height, age, color, and breed of horse

3. Registration/ Passport:

Is the horse registered (i.e. Passport, Jockey Club, Warmblood Breed Registry, APHA, AQHA, NRHA, etc)? If so, I need a copy of the horse's papers. The best way to send a copy is to me is to scan and email. In particular on the passport, I need the main page that has the horse's number and date of birth, and I need the pages with the lineage of the sire and dam.

4. Purchase price and date:

When did you purchase the horse and what was the purchase price? If the horse is a homebred, please include information about the sire and dam including stud fee, or any other information about bloodlines that are pertinent to the appraisal.

5. Show record/ Training:

What was the horse doing prior to purchase, and what has he/ she done since the purchase? How much professional training has been put into the horse (time and \$)? Any show record? How much have you invested in the horse in training and showing? Be as detailed as possible with all this information, especially the show record (prior to ownership and since you purchased the horse). This info will determine the horse's value more than anything else.

6. Location:

Where is the horse located (farm or school name and <u>street address</u>)?

7. Owner's information:

Please include the owner's complete name, phone number, and email. Please be sure to give me the exact name you use to file your taxes. If you are an agent, please also provide your name and contact info.

8. Estimated value:

What amount do you value your horse at? What would you set as the horse's purchase price? What is the horse insured for if he/ she is insured?

9. Video/ pictures:

Please send me a video of the horse unless we discussed me coming to see the horse in person. I can do the appraisals for donations by a recent video, and the video needs to be indicative of what the horse is currently capable of doing. You can send a video by emailing me a Youtube link or other link, text it to me, or you can send it to me through Facebook Messenger or What's App (I am on those platforms as Kat DeMas Mulkey. For What's App, my phone number is 706-474-8490). If you have a few pictures, please

email or text a copy of those as well. It is especially helpful to me if they show your horse's markings in detail.

10. Appraisal Fee:

I charge \$600 to complete the appraisal. I will send you an invoice when I send you the appraisal. You can pay me through Venmo or by mailing a check. I am on Venmo as Kat DeMas Mulkey.

I am very happy to do this appraisal for you, and I will complete it for you as promptly as I can. I can usually get the appraisal completed within a week of getting all of the information from you. Thank you for contacting me, and please let me know if you have any questions at all!
